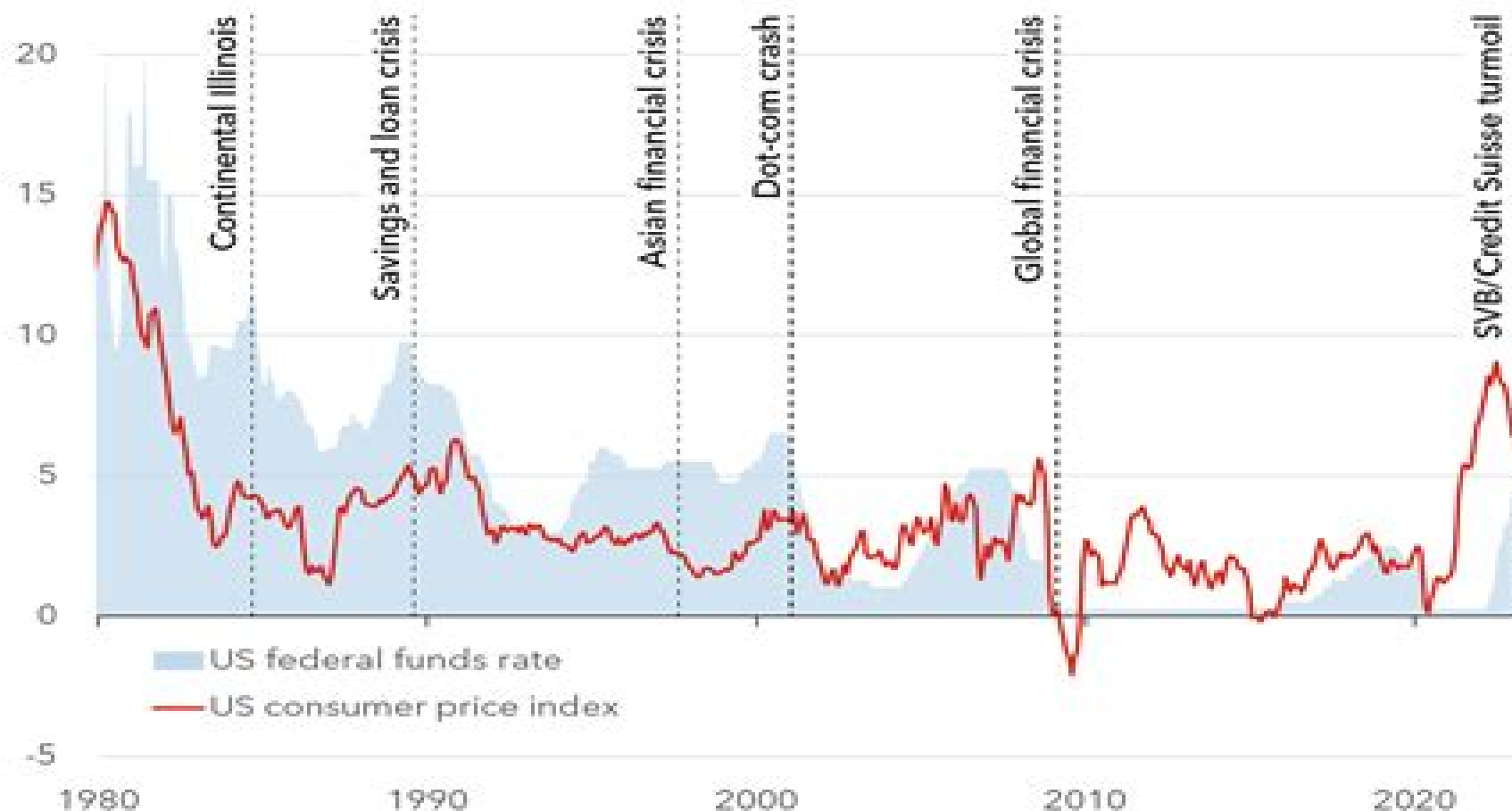


Rate hikes and financial stress

of Greece the client country would trigger a panic of banks and other creditors and thus generate contagion for the rest of Europe Learning from the Greek case in Ireland and Portugal the IMF pushed for debt reduction to which the government in Ireland but not in Portugal was sympathetic There was thus no private sector debt reduction in Ireland and Portugal The European programs were caught up in big geopolitical debates about the appropriate role of the Fund in the aftermath of the global financial crisis The book examines the intellectual and policy shifts that took place in the IMF as a result of the controversies about its European programs It concludes with some reflections on how all the programs also produced genuine policy reform and held out the possibility of a return to growth and prosperity *Redefining European Economic*
