

CHAPTER 2

Taxation Law

- refers to any law that arises from the exercise of taxation power of the state. It serves as the basis of taxing the individual or property to avoid conflict because it states the duties and obligations of the government and people. Taxation also includes duties on imports from foreign countries and all compulsory levies imposed by the government upon individuals for benefit of the state.

Types of Taxation Law

1. **Tax Laws** – these are the laws that cover the collection of taxes which the government has a claim on taxpayers, requiring them to transfer a part of their income or property to the authority for the benefit of the state.

Examples:

- **The National Internal Revenue Code (NIRC)**
 - taxes professionals and self-employed individuals, such as lawyers and doctors, at the same rate as wage earners.
 - Around eighty percent (80%) of tax revenues derived from individual taxpayers is collected from the wage earners or salaried taxpayers. Only twenty percent (20%) is collected from self-employed individuals and professionals.
- **The Tariff and Customs Code (RA 1937)**
 - Its Tariff duties are levied on imported goods either as a revenue generating measure or a protective scheme to artificially or temporarily inflate prices to support the local industries of a particular country and protect its domestic output from their foreign counterparts.
- **The Local Tax Code (Presidential Decree No. 231)**
 - this Code governs the exercise by provinces, cities, municipalities, and barrios of their taxing and other revenue-raising powers. Local government units (LGUs) derive their revenues from local and external sources. Local sources include tax revenues from the real property tax and the business
