Export of Senices Rules under Senice Tax.

The Export of service Rules, 2005 were notified with effect from 15-03-2005 to determine whether a provision of service will be regarded as export of service. Like export of goods, service can also be exported without payment of durytax.

So before we move on to export our services outside India, let us understand in brief the basic conditions required to be fulfilled, so that it can be treated as Export of service.

As per clause (1) of rule 6A of service tax rules, any service provided or agreed to be provided shall be treated as export of service if all the below mentioned conditions satisfied cumulative by

#### A. The provider of service is located in the taxable territory :-

The first condition to be satisfied in that the service provider must be located in the tanable territory. Under section 659(52) of the act, the term 'taxable territory' means the territory to which the provisions of the act apply. Under section 64(1) of the act, the act extends to the whole of India except the State of James & Kashesir.

From a combined reading of the aforesaid provisions, it is clear that the term 'tanable territory' means 'bulia' soless the State of Jamera & Kashmir.

It is also clear that any service provider located in the State of Jamess & Kashinir Carent be treated as an 'exporter'.

#### B. The Recipient of service is located outside India :-

The second condition to be satisfied in that the recipient of service (service receiver) must be located outside fridis. This means that the service receiver must be located outside the territorial limits of Iralia, including the State of James & Kashmir.

If service provider is located within the State of Jamma & Kashmir, the case will not full under "Export of Service".

#### C. The service is not a service specified in section 66D of the Act :-

The third condition to be satisfied is that the service must not be a service specified in the Neutrice List spek out in section 66D of the Act.

#### Exemption of Services -Notification No. 25 dated 20.06, 2012 undated till date

#### D. The place of previous of the service outside India :-

The Earth condition to be satisfied in that the place of provision of the service must be outside India. The fulfillment of this condition will have to be determined in accordance with the place of provision of service Inid down in Rules 3 to 14 of the PPP Rules which are as follows:
