Using MATLAB, carefully select two images of your own choice to create landmarks on both images.

1. Select two images, `im1` and `im2`, of exactly the same size (you can resize the images using `align_images.m` if necessary)
2. Use MATLAB function `cpselect(im1, im2)` to define at least 40 pairs of corresponding landmarks on the two images by hand (more landmarks means better morphing)
3. Save the resulting two sets of landmarks
4. Use MATLAB function `plot` or `scatter` to show resulting images with landmarks
5. Store the resulting two sets of landmarks as text files.
6. Store the resulting images (with landmarks on them) as jpg files.
