

## H 2 - L'affirmation de la puissance américaine depuis 1918.

*La puissance désigne la capacité d'un acteur, généralement un Etat ou un groupe d'Etats, à exercer une influence sur le comportement des autres. Si, à la fin de la Première Guerre mondiale, les Etats-Unis s'affirment comme la seconde économie-monde après la Grande-Bretagne au XIX<sup>e</sup> siècle, ils paraissent constituer, aujourd'hui, une puissance complète s'imposant dans tous les domaines.*

*Comment expliquer l'affirmation de la puissance américaine au cours du XX<sup>e</sup> siècle ?*

*De 1918 à 1945, les Etats-Unis hésitent à imposer leur domination sur le monde. Puis, de 1945 à 1991, ils deviennent le leader du « monde libre ». Enfin, après 1991, l'hyperpuissance américaine est contestée.*

### I. Les hésitations de la puissance américaine : entre isolationnisme et interventionnisme (1918-1945).

*De 1914 à 1945, les Etats-Unis vont hésiter entre deux attitudes : l'isolationnisme et l'interventionnisme. Contraint d'entrer en guerre lors de la Première Guerre mondiale, ils s'isolent rapidement des affaires européennes suite à la crise de 1929 et ce n'est qu'avec l'attaque japonaise de 1941 que les Etats-Unis décident d'entrer dans la Seconde Guerre mondiale.*

#### A. De l'espoir d'un nouvel ordre mondial à l'isolationnisme (1918-1920).

Depuis leur indépendance en 1776, les Etats-Unis se tiennent à l'écart des affaires européennes. Cet isolationnisme est symbolisé par la doctrine Monroe mise en place en 1823. Selon celle-ci, les Etats-Unis n'interviennent pas dans les affaires de l'Europe et s'opposent à toute intervention européenne sur le continent (« l'Amérique aux Américains »). Ils estiment avoir pour mission de maintenir la paix et de faire respecter le droit sur le continent américain. Lors de l'éclatement de la Première Guerre mondiale, le gouvernement américain proclame sa neutralité afin de respecter l'isolationnisme avec le soutien de la population. Même après l'attaque du paquebot Lusitania le 7 mai 1915 et la mort de 200 citoyens américains, les Etats-Unis restent neutres en raison d'un ralentissement de la guerre sous-marine menée par les Allemands. Il faut attendre 1917 pour que la position américaine change. En effet, en février de cette année, les Allemands souhaitent relancer la guerre sous-marine entraînant un blocus des Etats-Unis et ont pris contact avec le Mexique pour que celui-ci attaque les Etats-Unis (télégramme Zimmermann). Aussi, le 6 avril 1917, les Etats-Unis entrent-ils en guerre aux côtés de l'Entente. Les Etats-Unis mettent en place la conscription et envoient plus de deux millions d'hommes en Europe. Cette infraction à l'isolationnisme doit permettre aux Etats-Unis de peser sur les futures négociations de paix.

Le 8 janvier 1918, le président américain Woodrow Wilson présente devant le Congrès les « Quatorze Points » devant permettre la paix dans le monde et la mise en place d'un nouvel ordre mondial. Ils reposent sur le droit des peuples à disposer d'eux-mêmes, la liberté du commerce et des mers ainsi que le maintien de la paix grâce à une organisation de sécurité collective chargée d'arbitrer les conflits, la future Société des Nations (SDN). Dans ce nouveau monde, les Etats-Unis ont pour mission d'étendre au monde entier les principes qui ont fait leur fortune : démocratie et libéralisme économique. Pour défendre ses idées, Wilson se rend à Paris pour participer à la conférence de paix, étant ainsi le premier président en exercice à se rendre en Europe. Malgré des réticences à ses idées (parti colonial contre le droit des peuples, France opposée à la participation des vaincus aux négociations), les « Quatorze Points » inspirent largement le traité de Versailles du 28 juin 1919 qui met fin à la guerre avec l'Allemagne même si Wilson aurait souhaité un traité moins dur avec l'Allemagne. A cette date, les Etats-Unis sont la première puissance industrielle mondiale, disposant d'une nombreuse population jeune et dynamique, d'un territoire riche en ressources et d'une flotte de guerre comparable à la marine britannique. Ils peuvent s'imposer comme la première puissance mondiale. Mais, le Sénat refuse de ratifier le traité de Versailles et donc de participer à la SDN. En novembre 1920, c'est le républicain Harding qui est élu président sur le thème du « retour à la normale » (i. e. l'isolationnisme) et avec pour slogan « *America first* ». Les lois de 1921 et 1924 restreignent l'immigration et les Etats-Unis se replient sur eux-mêmes.

*Après leur intervention lors de la Première Guerre mondiale, les Etats-Unis tentent d'organiser un nouvel ordre mondial mais, rapidement, se referment sur eux-mêmes.*
