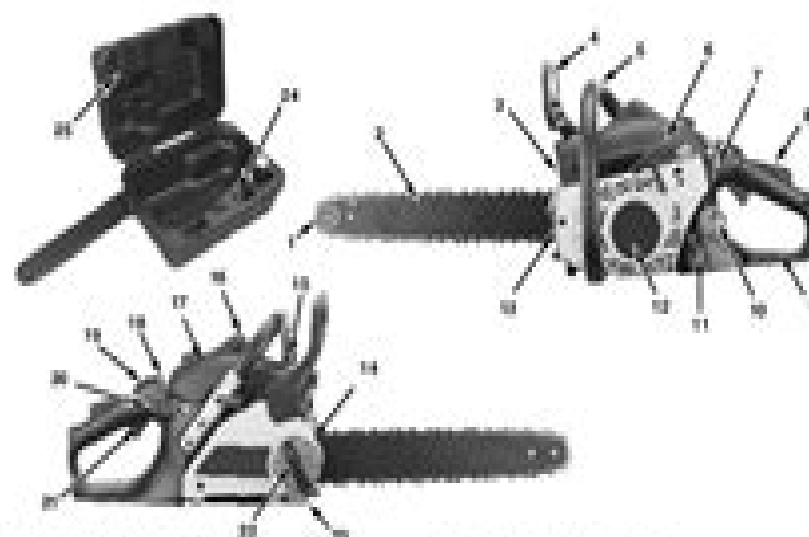

1-2. SAFETY FEATURES

1. **LOW BACKSACK SAW CHAIN** helps significantly reduce kickback, or the intensity of kickback, due to operator designed safety pages and guard bars.
2. **CHAIN BRAKE™** lockback guide bar reduces the intensity of kickback.
3. **SPARK ARRESTER SCREEN** reduces carbon and other combustible particles over 0.002 inches (0.05mm) in size from engine exhaust flow. Compliance with local, state and federal laws and/or regulations governing the use of a spark arrester screen is the user's responsibility. See Safety Precautions for additional information.
4. **CHAIN BRAKE™ LEVER / HAND GUARD** protects the operator's left hand in the event it slips off the front handle while saw is running.
5. **CHAIN BRAKE™** is a safety feature designed to reduce the possibility of injury due to kickback by stopping a moving saw chain in milliseconds. It is activated by the (Chain Brake™) lever.
6. **STOP SWITCH** immediately stops the engine when tripped. Stop switch must be pushed to ON position to start on restart cycles.
7. **SAFETY TRIGGER** prevents accidental acceleration of the engine. Throttle trigger (21) cannot be depressed unless the safety lock is depressed.
8. **CHAIN CATCHER** reduces the danger of injury in the event saw chain breaks or derails during operation. The chain catcher is designed to intercept a whipping chain.
