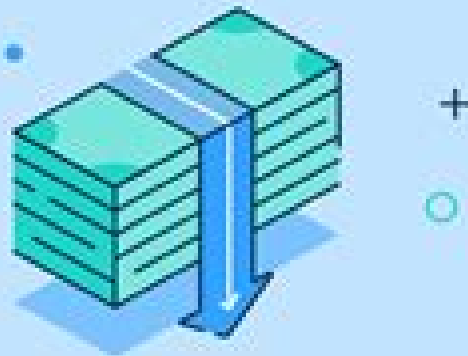


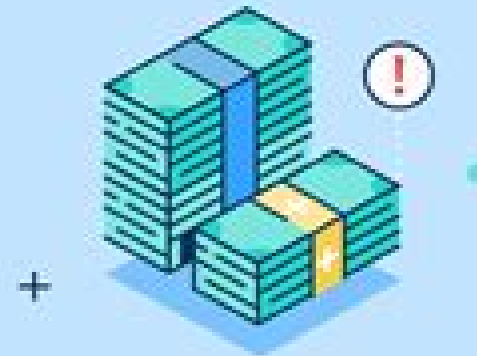
What happens during the bankruptcy means test?
