A partner who acts in terms of his or her mutual mandate can only bind the partnership to transactions which fall within the scope of the partnership business.

Each partner has the implied authority to perform all acts which are incidental to the proper conduct of the business.

Thus: third parties who wish to hold the partnership liable for a contract that was concluded by a partner have to prove that the specific contract fell within the scope of the partnership business. They do not need to prove that the partner had the necessary authority to conclude the agreement on behalf of the partnership.

In this case the parties agreed that no partner had the authority to conclude contracts of more than R10 000.

The court may find a corporation not to be a juristic person if it finds that the incorporation of the corporation or any act by or on behalf of it constitutes a gross abuse of its juristic personality as a separate entity.
