## IFRS

Used in over 140 countries, including the EU, UK (for listed companies), and many international markets. Not accepted in US for domestic issuers.

## US GAAP

Strict, rules-based system; mandatory in the U.S. for public companies and widely used by U.S.-based private firms. Exceptions for Foreign Private Issuer (FPI).
