#### Autotitionment instrumentions

- All reversals have been correctly processed as at 1 July 2012, expect for the following:
  - a. The loan with Halfway Bank had been taken out on 1 January 2012 and is to be repaid in full on 1 January 2014 (two years later). Halfway Bank charges interest of 4% per annum to be paid annually in arrears. The first interest payment was due on the 31" December 2012.
