The Personal Tax Credits Return - TD1 (Federal) is completed by an employee who: - has a new employer or payer and is receiving salary, wages, commissions or any other remuneration

- wishes to increase the amount of income tax deducted at source
- wishes to claim the deduction for living in a prescribed zone
- has changes in the personal tax credit amounts previously claimed on a TD1

The information on the TD1 is used by the employer or payer to: - Determine the amount of federal and provincial/territorial income tax to deduct from an individual's employment income or other income such as pension income.

The Worksheet for the Personal Tax Credits Return - TD1-WS is used to calculate partial claim amounts on the TD1 for: - age

- caregiver
- infirm dependant age 18 or older

In what situations would an employee complete the federal Worksheet for the Personal Tax Credits Return - TD1-WS? - To calculate partial claim amounts for age, caregiver and/or infirm dependant age 18 or older.

When does the claim code on the employee's federal TD1 have to match the claim code on the provincial/territorial TD1 - When a non-resident employee has a claim code of 0 on their federal TD1.

Applicable provincial/territorial tax rate: the employee works at the employer's premises - The province/territory where the premises is located.

Applicable provincial/territorial tax rate: the employee does not work at the employer's premises - The province/territory of the employer's office from which the employee is paid
