To get started, they have gathered the following information about their main competitors: Expert HVAC Corporation's negative earnings per share were the result of an accounting write-off last year. Without the write-off, earnings per share for the company would have been \$1.06.

Last year, Ragan, Inc., had an EPS of \$4.54 and paid a dividend to Carrington and Genevieve of \$63,000 each. The company also had a return on equity of 25 percent. The siblings believe that 20 percent is an appropriate required return for the company.
