**NOTE: DO NOT OPEN BOTH VALVES AT ONCE.** Do not open the Gray Waste Tank Drain valve until the black tank is drained and Black Waste Tank Drain valve closed to avoid sewage back-up into gray tank. Gray water also rinses any black water solids from the sewage drain hose.

6. Close sewage drain hose valve by pulling handle up until lock snaps into place (if equipped).

**NOTE:** If the sewage drain hose will not collapse while storing, open the sewage drain hose end valve (if equipped) to release air trapped inside the hose.

8. Add an odor control chemical to the black waste holding tank through the toilet. The chemicals are available at most RV stores.

**NOTE:** We recommend that you dump the holding tank's contents.
