

CHAPITRE 1 : LES SOURCES DES OBLIGATIONS

Obligation : lien de droit entre deux ou plusieurs personnes. Si l'on prend le lien entre 2 personnes, c'est le créancier (coté positif de l'obligation) et le débiteur (coté négatif de l'obligation).

Il y a 2 types d'obligations :

- **L'obligation civile**, signifie qu'en cas de non respect de cette obligation celle-ci a vocation à être sanctionnée par l'intervention judiciaire. Le créancier va pouvoir faire valoir son obligation auprès des juges.
- **L'obligation naturelle**, elle a cette particularité de ne pas pouvoir être sanctionnée par le juge. Elle est très proche d'un devoir morale.

En droit il y a 5 sources d'obligations.

I / Les obligations d'origine légale

Les obligations d'origine légale sont très nombreuses et sont étudiées avec la branche du droit qui les prévoit : c'est ainsi que l'obligation alimentaire, par exemple, est étudiée avec le droit des personnes et de la famille.

II / Les obligations d'origine délictuelle ou quasi-délictuelle

Article 1240 : « tout fait quelconque de l'homme, qui cause à autrui un dommage, oblige celui par la faute duquel il est arrivé, à le réparer ».

Il ne faut pas confondre la **responsabilité civile** avec la responsabilité pénale. La responsabilité pénale a pour obj de sanctionner un comportement d'un individu, ou d'une société. L'obj de la responsabilité civile est de **réparer le dommage qui a été causé à autrui**.

La différence entre une **responsabilité civile délictuelle ou quasi-délictuelle** :

- Quasi-délictuelle : le dommage est causé de manière non intentionnelle (par imprudence, inconscience...).
- Délictuelle : le dommage causé par autrui a été provoqué de manière intentionnelle.

La responsabilité civile délictuelle ou quasi-délictuelle doit être également distinguée de la responsabilité civile contractuelle.

III / Les obligations d'origine quasi-contractuelle

Avec le quasi-contrat, une obligation naît, pour celui qui en profite d'un fait accompli par une autre personne, en dehors de tout contrat, mais qui engendre des conséquences comparables à celles qui naîtraient d'un contrat.

1) La gestion d'affaire

Selon l'**article 1301**, « celui qui, sans y être tenu, gère sciemment et utilement l'affaire d'autrui, à l'insu ou sans opposition du maître de cette affaire, est soumis, dans l'accomplissement des actes juridiques et matériels de sa gestion, à toutes les obligations d'un mandataire. »

En outre, le gérant « est tenu d'apporter à la gestion de l'affaire tous les soins d'une personne raisonnable ; il doit poursuivre la gestion jusqu'à ce que le maître de l'affaire ou son successeur soit en mesure d'y pourvoir. » (article 1301-1).
