- After five years of contribution, increase contributions by 1% of eligible pay up to \$1,000.
- Continue automatic contributions, increase by 1% each year thereafter, until you reach 10% of eligible pay.

Eligibility

To qualify to be eligible for the Matching Contribution Program, you must be 21 years old and have 40 hours of service. Once you have completed 40 hours of service, starting a 12-month period, you can receive the employer contributions with automatic contributions.
