 motivated by it
 - d. Was there a valid acceptance?
 - General rule: An offer to bargain in the unilateral mode can only be accepted by total completion of the requested act
 - ii. Exception: Once the offeree begins the substantial performance of the requested act, he does n/ form the Kbut he does cut off the power of the offeror to revoke so as to give the offeree a <u>reasonable opportunity</u> to complete that which he has begun.
 - e. Was there consideration (bargained for legal detriment on both sides of the exchange)?
 - i. Was there a promise to perform an act which, but for this bargain, the offeree was n/legally obligated to perform?
