among other types. The HPV vaccine is recommended for both male and female adolescents and young adults.

#### CANCER SCREENINGS

CERVICAL CANCER Lab test



A Pap smear screens for abnormal cervical cells. It should be performed every 3 years, starting when a woman is about 21 years old, with less frequent tests after 30.

BREAST CANCER X-ray



A mammogram scans breast tissue for tumors or other abnormalities. It is typically performed for the first time when a woman is between 40 and 50 years old, and repeated every 1 to 2 years.

COLORECTAL CANCER Camera or lab test



A colonoscopy allows a physician to look inside the large intestine for any abnormalities. It should be performed at 50 and repeated every 10 years. An annual home stool test is available for average-risk patients.

LIPID PANEL Blood test



A lipid panel measures cholesterol levels to determine if someone is at an increased risk for a heart attack or stroke.

DIABETES SCREENING Blood test



A Hemoglobin A1c test measures blood sugar control over the past three months. It can be used to diagnose diabetes or prediabetes.
