Officer Keane Reeves has been serving the ninth district of the city of Warhol in the state of Ceorgia or over ten years. He was first inspired to become a police officer after witnessing two officers beating a suspect that they had just arrested, simply out of spite for having caught him. Officer Reeves was just a child at the time, but he vowed to become a police officer that would be able to reshape the department and bring true justice. His biggest inspiration was his mother, who encouraged him to be a protector of the people, rather than protecting himself from the people.

EXAMPLES

A graduate of Percy High School in Warhol. Officer Reeves is a native to Georgia and the Warhol area. After graduating high school. Officer Reeves obtained an associate's degree in Paralegal Studies from Roanoke County Community College. He worked for two years as an assistant to a criminal lawyer, hoping to gain knowledge about the legal system. He left his position in 2004. disturbed at the amount of injustice he had observed in his work. He joined the ninth district city police later that year, and demonstrated himself to be a calm and fair officer who was trusted by the community.

In 2015, he was promoted to Deputy, and he began to make changes in the structure of the police department. He implemented the use of body cameras for all officers, and insisted on accompanying a random officer each night on making rounds across the city. During his tenure as deputy, the number of complaints received about police conduct have dropped by half. Officer Reeves is currently working on an outreach mission to unite the community and police officers in informal discussions, in order to restore trust in law enforcement over recent tensions in the community.
