

Ernesto A. Miranda v. State of Arizona (1966)

- **Facts:**
 - **Parties:**
 - Plaintiff: Ernesto A. Miranda
 - Defendant: State of Arizona
 - Ernesto Miranda was arrested in his house and brought to the police station. Miranda was questioned by police officers in connection with a kidnapping and rape.
 - After two hours of interrogation, the police obtained a written confession from Miranda. The written confession was admitted into evidence at trial.
 - Police officers admitted that they had not advised Miranda of his right to have an attorney present during the interrogation.
- **Procedural Posture:**
 - The Superior Court, Maricopa County, Arizona, rendered judgment.
 - On appeal, the Supreme Court of Arizona affirmed holding Miranda's constitutional rights were not violated because he did not specifically request counsel. United States Supreme Court grants Writ of Certiorari.
- **Issue:**
 - Does the Fifth Amendment's protection against self-incrimination extend to the police interrogation of a suspect? **(YES)**
- **Holding:**
 - Chief Justice Warren held that the Fifth Amendment requires that law enforcement officials advise suspects of their right to remain silent and to obtain an attorney during interrogations while in police custody.
- **Rationale:**
 - 5-4 majority
 - The privilege of Fifth Amendment is the protection against self-incrimination and thus must have procedural safeguards required to properly secure those rights.
 - The defendant is required to be formally warned by law enforcement before questioning, and while in custody:
 - that he has the right to remain silent, and that anything he said can be used against him in a court of law.
 - that he had the right to an attorney, and if he could not afford an attorney, one was to be appointed for him prior to any questioning if he so desired.
 - After these warnings are given, a defendant can be knowingly and informed enough to waive these rights and agree to answer questions or make a statement with knowledge of his rights.
 - Evidence obtained as a result of interrogation was not to be used against a defendant at trial unless the prosecution demonstrated the warnings were given, and knowingly and intelligently waived.
 - Mr. Justice Harlan, Mr. Justice Stewart, and Mr. Justice White dissented; Mr. Justice Clark dissented in part.
