$$= \frac{60!}{31!29!} \left(\frac{62 \cdot 61}{32 \cdot 30} - 1 \right) = \frac{60!}{31!29!} \frac{2822}{32 \cdot 30}$$

$$\alpha = \frac{2822}{32} \implies 16\alpha = 1411$$
