So what is it?

Businesses must maintain accounts not just by law, but to enable to see their income/expenditures in order to assess their businesses financial position. They may need to report these financial results to its owners. And also to act as a basis for computing tax.

The balance sheet is also known as “statement of financial position” (SOFP) and can simply be explained as:

Assets	Liabilities
House	Mortgage
Bank	Loan
Cash	Overdraft
Clothes	Gas bill
Total	Total

Accounting equation is as follows:

Assets = liabilities + capital OR liabilities = assets – capital

At the end of the financial year

Total asset = total sources of finance

- A balance sheet lists what a business owns and owes
- It shows assets and how they are financed
- Assets are financed by owners, long term liabilities and short term liabilities
- Vertical format calculates owners equity as:

Fixed assets

+ current assets

-current liabilities

-non current liabilities

=net assets
