#### Scope of this Practice Direction

- 1. I This practice direction applies where an application is made for
  - CAS a madelineouslad conduct;
  - (6) on order under section 27 of the 1973 Act;
  - Grb. on order under section 35 of the 1973 Act;
  - (4) an order under the 1973 Act which is made in connection with, or with proceedings. For any of the above orders, or
  - (v) an order under Part 3 of the 1984 Act.

#### Polygamous marriages

- 2.1 Where this practice direction applies the application must state—
  - (ai) that the marriage is polygamous;
  - (A) whether, as far as the party to the marriage is aware, any other spouse (that is, a spouse other than the spouse to whom the application relates ) of that party is will firting (the "additional spouse"); and
  - 14.5 If there is such an additional speake -
    - the additional spoose's name and address;
    - (ii) the date and place of the marriage to the additional sevene.
- 2.2. A respondent who believes that the marriage is polygamena must include the details refirmed to in paragraph 2.1 above in the acknowledgment of service if they are not included in the application.
- 2.3 The applicant in any proceedings to which this practice direction applies must apply to the court for directions as soon as possible after the filling of the application or the receipt of an acknowledgment of service mentioning an additional secure.
