The defendant subsequently moved to suppress the teller's testimony, claiming that the lineup violated his privilege against selfincrimination. At the suppression hearing, the teller testified that she had not gotten a good look at the robber's face, because the robber had been wearing a hat pulled down over most of his face, but that she was certain the defendant was the robber because she had recognized his voice at the lineup.
