Both partners and the partnership file Federal income tax returns at the IRS Service Center in Ogden, Utah.

The partnership files its tax return on the accrual method. Inventory has been consistently valued at cost under the FIFO method using the full absorption procedure. Inventory capitalization rules of Internal Revenue Code Section 263A do not apply due to the "small business exception" (average annual gross receipts for the three preceding taxable years do not exceed \$10 million). The accounting records are computerized.
