The judicial branch is responsible for interpreting the Constitution and laws. It is made up of the Supreme Court and lower federal courts. The Supreme Court is the highest court in the land and has the final say on all cases.

Lower federal courts are responsible for hearing cases that involve federal law. They are organized into circuits, with each circuit having a court of appeals. The Supreme Court is made up of nine justices, who are appointed by the President and confirmed by the Senate.

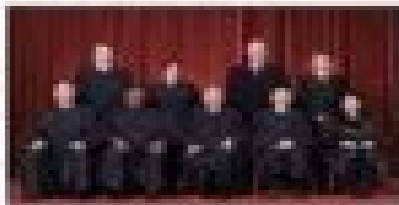
