Schlosser,2015 U S Marines in Irregular Warfare Training and Education is a brief history that recounts how the U S Marine Corps adapted to fight the Global War on Terrorism during 2000 10 The Marine Corps has a long history of fighting irregular wars including the Banana Wars in Central America during the 1920s and the Vietnam War during the 1960s To battle the insurgencies in Iraq and Afghanistan the Corps drew upon this

experience while also implementing new plans and programs to better prepare Marines to carry out counterinsurgency operations The Marine Corps updated the curriculum at the Command and Staff College and transformed the annual Combined Arms Exercise into Exercise Mojave Viper an immersive training program that simulated the urban environments in which Marines would be operating in Southwest Asia Most importantly Marines adjusted in the field as battalion and company commanders drew on their basic training and education to devise innovative tactics to better combat the new threats they now faced as this story shows the Marine Corps did not undergo a radical transformation to fight in Iraq and Afghanistan but instead drew on principles that had defined it as a warfighting organization throughout most of its history

the fog of war 4 a Warfighter who embraces the Corps warrior ethos and 5 mentally strong and physically tough The universal concept that Marine Officers must be able to assess situations weigh the pros and cons of various decisions make a decision develop a plan communicate that plan effectively and supervise its execution is stressed and exercised throughout the course The course will teach the science and art required for service of Marine Officers with an emphasis on decision making throughout Provisional infantry and planning subjects are together used as the means or vehicle to teach and evaluate this process Since all students are evaluated on leadership as Marine Officers physical mental and emotional stress are incorporated throughout the course in order to evaluate the ability to lead in chaotic and stressful environments Some individuals will be pushed close to their failing point but the WOBC is designed to give students an opportunity to display positive leadership qualities in the face of adversity The WOBC is not a check in the block It is a course designed to provide students with the learning experiences necessary to effectively transition to service as a Marine Officer Students who do not successfully complete the course face a variety of administrative actions including repetition of the course recycle to a six month lieutenant Basic Officer Course revocation of appointment or separation from the service The WOBC curriculum is an academically rigorous provisional infantry and staff planning based program of instruction POI which consists of approximately 935 hours of formal instruction The POI includes classroom instruction field exercises sand table exercises and discussion groups Classroom instruction is designed around the flipped classroom model

Tarawa and The Road to Big Week Reviewed by Book News Hammel a noted military historian and author analyzes the military build up in the United States just prior to World War II and notes how this strategy was deliberate orderly and integrated Written for history buffs and general readers this volume characterizes the U S as a sleeping giant after the end of World War I as a new shift toward an expanded military industrial complex was implemented creating an Arsenal of Democracy that would ultimately decide the outcome of World War II Appendices include a list of the armies corps regiments and divisions in the Army and Navy as well as a list of major naval and aircraft hardware Reviewed by Bookviews The Forge by Eric Hammel tells how preparation for war was the reason that following the Japanese attack on Pearl Harbor in 1941 the nation was able to transition quickly to an offensive war This excellent book tells why America was able to transform itself into what FDR called the arsenal of democracy fielding armies in both the Asian and European theatres while providing them with countless tanks and ships and guns America may have been a sleeping giant when it came to the political events unfolding but the decision to turn the entire force of American industry toward the task of winning World War II had been made long before the initial attack on the homeland It had in fact begun in 1938 as the war clouds threatened Those who criticize America s current superpower status would do well to read this book and then wonder if preparing for war isn t the best way to maintain the peace Reviewed by Tom Ricks on his blog The Best Defense Readers of this blog will know that I am a fan of military historian Eric Hammel I ve been reading his new book The Forge about the quiet fight at the end of the 1930s to prepare the U S military for World War II This is not only an important story but also a good read with a strong grasp of significance By the end of November 1941 the British army in North Africa on its only active front against European fascism was utterly stalemated in a battle of attrition it was bound to eventually lose The subsequent counterattack at el Alamein was undertaken he notes with the aid of weapons and equipment made in America not to mention American manned combat aircraft Reviewed by BookLoons Perhaps not everyone will agree with the opinions set forth in The Forge but Eric Hammel provides some strong arguments that the country was far better prepared for the Second World War than most people believe Those interested in U S history especially military matters will find this a captivating read and one that may alter a few misconceptions about U S preparedness between the world wars
