Overview

Topics in the course will be studied through classroom discussion, lectures, notes, labs, student presentations, and videos. The videos used in the class will be from broadcast television shows such as the Discovery Channel, The Weather Channel, Bill Nye and video available through BOCES and Crandall Public Library. All videos have been prescreened and are appropriate for a High School Physics class. If you have any questions about the videos that will be shown throughout the course please contact me.

The Physics class will meet in a 40-minute class period followed by a 20-minute lab period every day. The lab portion is essential because it reinforces what is taught in class and must be kept up to date. Lab and lecture times tend to overlap so a student may miss a laboratory segment if they are not present in class. The Physics class is a Regents credit course. Therefore we will move rapidly through the material in order to cover all topics. Below is a summary of each unit we plan to cover:

- Unit - 0: "Math Basics" is a review of the various mathematical tools that students will need during the year. Students will review: algebra, trigonometry, significant digits, scientific notation, graphing, and unit conversions. There will be no assessments in this unit.
- Unit - 1: "Kinematics" is the study of objects in motion. Students will learn how to describe motion using qualitative, quantitative, and graphical methods. This unit includes both one and two dimensional motion.
- Unit - 2: "Dynamics" is the study of forces and their effects on solid bodies. Students will learn about Newton's Laws of Motion, how to use vectors to create free-body diagrams, the effects of friction, and the behavior of objects on inclines. Additional sub-
