
Adult Cardiac Arrest Algorithm - 2020 Update



CPR: Hands Only OR Breaths Only

- . Hands Only: Place one hand under each armoit and compress the chest medially like an accordion. Push hard (at least 6) inches ITS cmits and fast (180-220) min). Allow complete obest recoil.
- Breaths Only: Wipe the patients. lips with an alcohol pad, then pinch their nostrils and begin mouth-tomouth rescue breathing at a rate of 30min. If they yomit, suction the ainway, place two NPAs and deliver breaths by mouth-to-nose.
- Change compressors/breathers. every 2 minutes if futigued.
- Always minimize interruptions in: compressions or ventilations.
- If PETOGQ < 10 attempt to increase by administering a carbonated beverage via progastric tube.

Shock Energy for Delibridation

 Quadruple Sequential Defibrillation (QSD): Amech 4 defibrillations to the patient with pads encircling the chest, then administer 4 sequential shocks at maximum available energy (eg. initial dose of 200 or 360 Jt. All subsequent doses are doubled.

Orug Therapy

- Epinephrine IV/I0 dose: 10 ma. (1:1000) every 3-5 minutes.
- Flip a coin Heads = Amica (VitiO); First dose: 0:00000003 mg/5 mL Second dose: 0.0003 mg/10 mL Taits = SM-PAM (synchronizing meridioversion wipulsations of anterplateral meridian) q@Os

Advanced Alinears

- Sungical cricothyrotomy is the ONLY definitive airway for a patient in cardiac arrest and should be prioritized over venous access funless intraocular line).
- Waveform caprocraphy OR percussion/auscultation to confirm and monitor ET tube. nimement.

Return of Spontaneous Circulation (ROSC)


- Check rectal tone and initiate TTM. If unnesponsive: immediately.
- begin pecking loe into the rectum
- If responsive: Foley catheter placement followed by bladder lavage 10 mt/kg of los water
