

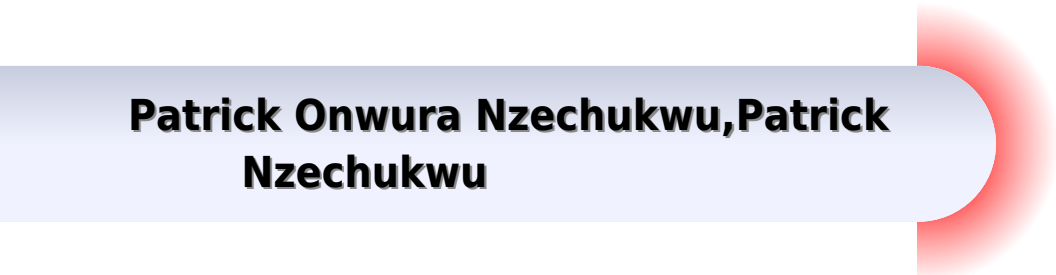
Basic structure of Audit report management

Format	Description
 1. Title	Mentions the type of auditor eg. Independent or dependent auditor
 2. Addressee	Mentions the person or company to whom the report is addressing eg. in case of statutory report, shareholder of the company is addressee
 3. Obligation of auditor	Mentions the responsibility of the auditor eg. perform an unbiased audit of financial reports and give opinions
 4. Scope of audit	Mentions the analytic ability of the auditor eg. provide assurance to shareholders about audit which is done according to auditing standards
 5. Judgment of the auditor	Mentions the opinion regarding reports eg. giving different opinions such as unqualified, qualified, adverse opinions on financial reporting
 6. Basis of judgment	Mentions the basis of opinions eg. provide facts, grounds on which opinions were based
 7. Signature of auditor	Mentions the auditor's signature eg. sign the report content at the end of report
 8. Place of signature	Mentions the location during signature eg. give the name of city in which report was signed
 9. Date of report	Mentions the period of auditing eg. provide date of audit report
 10. Date of signature	Mentions the closing date eg. provide date on which audit report was signed
