STEPS TO WRITING A WORKPLACE INCIDENT REPORT



1. TAKE IMMEDIATE ACTION

Employees should notify their manager or another member of the company's leadership as soon as the incident occurs. Once an incident has been reported, the member of leadership's first responsibility is to ensure that appropriate treatment, if necessary, is being administered to those affected by the event.



2. COLLECT THE FACTS

Once the immediate action including the response to the event and eliminating the hazard from the environment has been conducted, determine and record the facts related to the incident. Facts can include.



3. ANALYZE AND REFLECT

Analyze and determine how and why the incident occurred in order to develop an effective corrective action plan.



4. ESTABLISH A CORRECTIVE ACTION PLAN

A Corrective Action Plan would provide recommendations as a means to reduce the possibility of a continued issue and/or recurrence of the incident. The recommendations would result from an effective analysis of the facts collected and documented in the incident report.

Incident reports are a not only a defining piece in any company's incident response protocol, but they provide a means to avoid recurring mishaps and/or inspire change. That's why it is crucial to have a relevant and comprehensive incident report form prepared and on hand for any incident that may arise.

Breaking these restrictions might require specific software or tools, which may or may not be legal depending on the circumstances and local laws.
