**Reason why Wilson was disappointed with the Treaty of Versailles was because he** wanted all countries to have self-determination. The reasons for this were twofold. The First World War was, in large part, caused by the hostility derived from growing nationalism in Europe, which underpinned those countries' expansionist aims as they sought to grow their empires larger and faster than their rivals. Therefore, Wilson wanted to eliminate this imperialistic culture would safeguard against a second major war. In addition to this, as an emerging superpower, America did not want its power or influence to be undermined by large European powers, whose empires extended across the globe. This was because the League would affect their economy too adversely. In Britain, 30,000 coal miners were already out of work, and America would not support such a sanction. Chamberlain believed he had secured peace after the Munich agreement because in the meeting prior to the agreement Hitler had assured him that all he wanted was the Sudetenland and the 3 million German speakers who lived there. The Munich Agreement gave Hitler exactly these things, and as a result Chamberlain believed Hitler would be content and compliant moving forwards. Hitler had also been the one to call the meeting which led to the Munich agreement. Therefore, Chamberlain felt more confident that Hitler was interested in diplomacy and wanted to find a peaceful solution as if he wasn't, it seemed unlikely he would have signed a peace declaration with Chamberlain.
