- An account is a form designed to record changes in a particular asset, liability, stockholders' equity, revenue, or expense. A ledger is a group of related accounts.
- The terms debit and credit may signify either an increase or a decrease, depending upon the nature
 of the account. For example, debits signify an increase in asset, expense, and dividends accounts
 but a decrease in liability, common stock, retained earnings, and revenue accounts.
- A. Assuming no errors have occurred, the credit balance in the cash account resulted from writing checks for \$1,850 in excess of the amount of cash on deposit.
 - B. The \$1,850 credit balance in the cash account as of December 31 is a liability owed to the bank. It is usually referred to as an "overdraft" and should be classified on the balance sheet as a liability.
- 4. A. The revenue was earned in October.
 - B. (1) Debit Accounts Receivable and credit Fees Earned or another appropriately titled revenue account in October.
 - (2) Debit Cash and credit Accounts Receivable in November.
- 5. No. Errors may have been made that had the same erroneous effect on both debits and credits, such as failure to record and/or post a transaction, recording the same transaction more than once, and posting a transaction correctly but to the wrong account.
- The listing of \$9,800 is a transposition; the listing of \$100 is a slide.
- A. No. Because the same error occurred on both the debit side and the credit side of the trial balance, the trial balance would not be out of balance.
 - Yes. The trial balance would not balance. The error would cause the debit total of the trial balance to exceed the credit total by \$90.
- 8. A. The equality of the trial balance would not be affected.
 - B. On the income statement, total operating expenses (salary expense) would be overstated by \$7,500, and net income would be understated by \$7,500. On the retained earnings statement, the beginning and ending retained earnings would be correct. However, net income and dividends would be understated by \$7,500. These understatements offset one another, and thus, ending retained earnings is correct. The balance sheet is not affected by the error.
- 9. A. The equality of the trial balance would not be affected.
 - B. On the income statement, revenues (fees earned) would be overstated by \$300,000, and not income would be overstated by \$300,000. On the retained earnings statement, the beginning retained earnings would be correct. However, not income and ending retained earnings would be overstated by \$300,000. The balance sheet total assects is correct. However, liabilities (notes payable) is understated by \$300,000, and stockholders' equity (retained earnings) is overstated by \$300,000. The understatement of liabilities is offset by the overstatement of stockholders' equity (retained earnings), and thus, total habilities and stockholders' equity is cottect.
- A. From the viewpoint of Surety Storage, the balance of the checking account represents an asset.
 - From the viewpoint of Ada Savings Hank, the balance of the checking account represents a liability.
