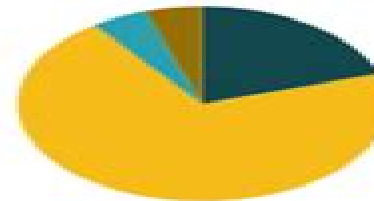

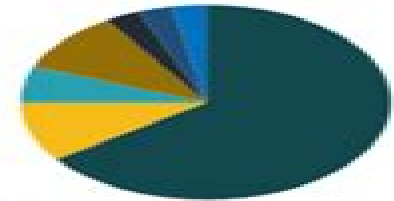
## Revenue vs Expenditure for Q1 2020

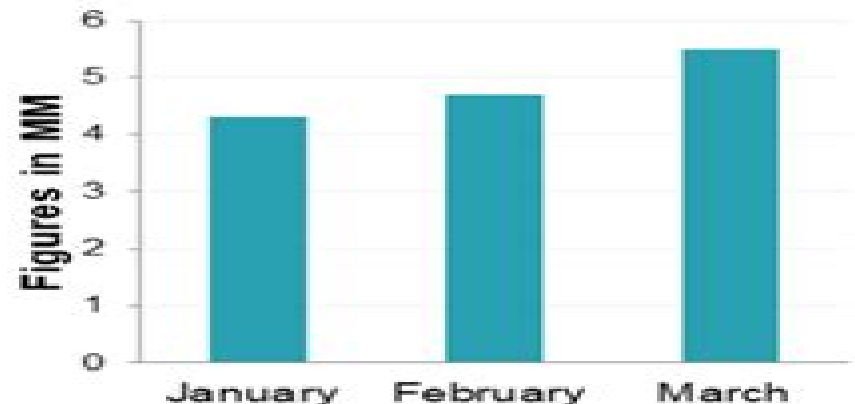
