In particular, the authors draw from social psychology research to show why justices are apt to follow the lead of the elite social networks that they are a part of. In an era of strong partisan polarization, elite social networks are largely bifurcated by partisan and ideological loyalties, and the justices reflect that division. Justices such as Clarence Thomas and Ruth Bader Ginsburg live largely in a milieu populated by like-minded elites. Today's partisanship on the Court also stems from the emergence of conservative legal networks such as the Federalist Society that reinforce the conservative leanings of Republican appointees. For the Warren and Burger Courts, elite social networks were dominated by liberal elites, and not
