communication It is argued that understanding the origins of the paths we use today contributes to appreciation of the distinctive qualities of landscapes Appreciation will help to bring about effective strategies for conservation of mutual benefit to people and wildlife by maintaining and enhancing corridors of connectivity between different landscape zones including fragmented nature reserves and valued places In these ways an understanding of past routeways can contribute to sustainable landscapes communities and quality of life
