- January 15, 2009, the U.S. Department of Health and Human Services (HHS) released two final rules supporting the continued transformation of the U.S. healthcare system toward a comprehensive electronic data exchange environment.
 - HIPAA 5010
 - ICD-10
- Represent the transaction code set components of the Health Insurance Portability and Accountability Act (HIPAA) of 1996.
- HIPAA 5010 Mandatory compliance on January 1, 2012 all covered entities
 - Internal Medicare testing began January 1, 2010
 - External testing began January 1, 2011
 - No entity may require another entity to use the new version of the standard without agreement between the two parties for testing and implementation.
