- Law is a rule or measure of action in virtue of which one is lead to perform certain actions and is restrained from the performance of others.
 - This is so because the very term which law is derived from comes from a Latin word meaning 'to bind'
- The rule and measure of human action is reason.
- It is reason that directs human action to its appropriate end
 - All forms of human action are guided by reason
- What is the relationship between law and reason?
 - Law is a form of human action law has resulted from human action. It is either legislated or created judicially.
 - If Reason is the rule and measure of human action, it is therefore the rule and measure of law.
 - Reason directs law to its appropriate end.
