ORGANIZATION

Preamble.

All Rules and Regulations pertaining to the administration of the State Board of Accountancy shall be administered by the State Accounting Office located at 200 Piedmont Avenue, Suite 1804 West Tower, Atlanta, Georgia 30334.

20-1-.01 Organization of Board. Amended.

The Board shall consist of seven members to be appointed by the Governor with the approval of the Senate. Any such appointment made when the Senate is not in session shall be effective until the appointment is acted upon by the Senate. Each member of the Board shall be a resident of this state. Six members of the Board shall be CPAs, all of whom shall hold a license to practice public accountancy issued under Code Sections 43-3-4, 43-3-5, 43-3-8. History. The officers of this Board shall be a Chairperson and Vice Chairperson, who shall be elected from the members at each annual meeting and shall serve for the term of one year or until their successors have been elected and qualified. The Board's Executive Director shall be the secretary of the Board. An annual meeting shall be held for the purpose of electing officers.
