





Checking Valve Clearance

IMPORTANT

- The valve clearance must be checked and adjusted when engine is cold.
- 1. Remove the cylinder head cover (1) and the glow plugs.
- Align the "1TC" mark (2) on the flywheel and alignment mark (3) on the rear end plate so that the No. 1 piston comes to the compression top dead center.
- Check the following valve clearance marked with "* using a thickness gauge.
- If the clearance is not within the factory specifications, adjust with the adjusting screw.
- Then turn the flywheel 6.28 rad (360 °), and align the "1TC" mark (2) on the flywheel and alignment mark (3) on the rear end plate so that the No.1 piston comes to the overlap position.
- Check the following valve clearance marked with "☆" using a thickness gauge
