- *European Commission Guidelines on Vertical Restraints - 2010/C 130/01*
- **Vertical restraints** = agreements or concerted practices entered into between two or more companies each of which operates, for the purposes of the agreement, at a **different level of the production or distribution chain**, and relating to the **conditions under which the parties may purchase, sell or resell certain goods or services**.
- Vertical restraints are generally less harmful than horizontal restraints and may provide substantial scope for efficiencies.
- In most cases, competition concerns can only arise if there is **insufficient competition at one or more levels of trade**.
