In this case, if she goes with Penwright, she would have to give up 25 years of exclusive publishing rights. That is more than 30% than what she would have to sacrifice if she goes with Woodville Press. Even more importantly, under Woodville's, she would still be able to include up to one chapter from the book in her publishes with absolute freedom. She will retain the ability to choose what excerpts she believes to be the most relevant to share with the public. As a matter of fact, this possibility not only fulfills the second objective of retaining rights but, it also speaks to the objective of maximizing her influence. She will have the autonomy to select which ideas can be published repeatedly. Whereas with Penwright, Cordero cannot use more than a few paragraphs without obtaining approval. This fact, in itself, violates the objective of retaining rights as much as possible over future use of the book's content.
