

**Item 1.** Indicate if you are taking a credit to reduce taxes due on the return. If "YES," complete and submit Form 31-148, Credits and Customer Broker Schedule, with your return. Examples of these credits include:

- Paying or paying for on a non-taxable or exempt purchase to enter:
- Taxes
- Manufacturing exemptions
- Normal and paid tax on the same taxable purchase.

**Sales:**

- Reporting tax on sales that qualify for an exemption:
- Taxes
- Manufacturing
- Agricultural/Timber

- Reporting tax on sales where merchandise is returned.

**Others:**

- Calculation of bookkeeping errors.

If you are claiming that credit to reduce your tax due, you must file electronically at [www.comptel-taxes.gov/taxesfile.asp](http://www.comptel-taxes.gov/taxesfile.asp). Claim the credit in Item 1 by subtracting the total of businesses and/or sales you paid taxes on in sales, or refunded to a customer, from the amount of taxable sales. Credit for a bad buying prohibition cannot be taken unless you have reported that prohibition on a previously filed tax return. A claim for refund must be filed directly with the Comptel. Refund instructions are available at [www.comptel-taxes.gov/taxes/taxrefunds](http://www.comptel-taxes.gov/taxes/taxrefunds).

**Item 2.** If you requested sales tax for items reported outside the 1-1-1 based on a Texas Licensed Customs Broker Export Certificate, you must complete and submit the Credits and Customer Broker Schedule (Form 31-148) with your return.

**Item 3.** 1 - If you have filed that you paid of business, you must file the total supplement (Form 31-170) with the Texas Sales and Use Tax Return, Item 1 - 7 on the sales supplement with the same as Item 1 - 7 on the Texas Sales and Use Tax Return (Form 31-170).

**Item 4.** Enter the total amount (not including tax) of ALL sales, services, leases and rentals of tangible personal property including all related charges made in Texas during the reporting period. Report whole dollars only. Enter "0" if you have no sales to report. Texas Sales are defined as all sales made from a Texas business location AND all sales made into Texas from an out-of-state location.

**Item 5.** Enter the total amount (not including tax) of ALL TAXABLE sales, services, leases and rentals of tangible personal property including all TAXABLE related charges made during the reporting period. Report whole dollars only and enter "0" if you have no sales to report. If you are taking a credit on the return, claim the credit in Item 1 by subtracting the total of businesses and/or sales you paid taxes on in sales or refunded to a customer, from the amount of taxable sales.

**Item 6.** Enter the total amount of taxable purchases that you made for your own use. Taxable purchases include items that were purchased, leased or rented for personal or business use or which sales or use tax was not paid. This includes purchases from in- or out-of-state sellers, exempt items taken out of inventory for use, items given away, and items purchased for an exempt use but actually used in a taxable manner. Taxable purchases do not include inventory items being held exclusively for resale. Report whole dollars only. Enter "0" if you have no taxable purchases to report.

**Item 7.** Add Taxable Sales (Item 5), Taxable Purchases (Item 6), and enter the result in Item 4. Do not include Total Texas Sales from 1-1-1. Report whole dollars only.

**Item 8.** To report total tax by seller, the amount subject to total tax must be the same for all total taxing authorities only, interest, county and in special purposes districts for that seller. If any of these total amounts are different for the seller, you MUST report your total tax on the Tax Supplement (Form 31-170). Report whole dollars only (\$00, not \$00.00). If "NOT APPLICABLE" is preprinted in Item 8, do not enter an amount. Credit for a bad buying prohibition cannot be taken unless you have reported that prohibition on a previously filed tax return. A claim for refund must be filed directly with the Comptel. Refund instructions are available at [www.comptel-taxes.gov/taxes/taxrefunds](http://www.comptel-taxes.gov/taxes/taxrefunds). If you are claiming that credit to reduce your tax due, you must file electronically at [www.comptel-taxes.gov/taxesfile.asp](http://www.comptel-taxes.gov/taxesfile.asp).

**Item 9.** Enter the largest number shown on your sales tax permit. If you have not received your sales tax permit and you are a sole trader, enter your Social Security Number. Other types of organizations may enter their Federal Employer Identification Number (EIN). If a taxpayer number has not been assigned.

**Item 10.** If the return is not preprinted enter the filing period of the report (month, quarter or year) and the last day of the period. Examples: "Quarter Ending 06-30-01" "Month Ending 10-31-01" "Year Ending 12-31-01"

**Item 11.** If you had sales to report in Item 1, 2 and 3 for all sellers during the filing period, check the box, sign and take this return and mail to the Comptel's office.

**Item 12.** Enter the trade name, actual location and five digit sales number shown on your sales tax permit for each seller you are reporting. Use street address. Do not use P.O. Box or Rural Route number. If you do not have a permit, leave sales number blank. If you are reporting sales from out-of-state locations, use sales number "00000". If the physical location (seller) is no longer in business, write "out of business" and date of closing (not in any state that is no longer in business). If the physical location address is different from the preprinted physical location address, make correction and in the incorrect information. If a new seller has been opened, write the sales trade name, actual location and opening date in a blank space on the return along with a brief description of the business.

**Item 13 and 14.** Multiply Item 4 by the state tax rate and enter in Item 13. Multiply Item 5 by the local tax rate and enter in Item 14. If your return is not preprinted, refer to the booklet, "Texas Sales and Use Tax Rates (Form 30-150)", for a list of the current city, interest, county and MPD rates. If "USE LST" is preprinted in Item 13, report the tax on the Texas List Supplement (Form 31-170).

**Item 15.** Combine the state sales tax due from all sellers (Items 13) and enter the interest in Column 4. Combine local sales tax due from Item 14 from all pages and enter the total tax in Column 5.

**Item 16.** The amount preprinted in Item 8 includes the amount of your prepayment plus the alternative prepayment discount. If you prepay timely and the amount is not printed in Item 8, calculate the credit by dividing the prepaid amount by .0025, and enter the result in Item 8. If the total tax due in other columns of Item 8 is greater than the prepayment, enter the difference in Item 10. Multiply the difference by .0025 and enter the result in Item 11. If the total due in other Item 8 is less than the prepayment credit in Item 8, enter the difference in Item 11a or 11b. Multiply the difference by .0025 and enter the result in Item 11. To determine the amount of refund, deduct the amount by Item 11. If you are filing your return or paying the tax due, check out the prepayment amount in Item 8 and enter the actual amount paid with your prepayment report. Note: Discount applies only if all prepayment requirements are met AND your regular sales and use tax return AND any additional payments are postmarked by the due date.

**Item 10.** Subtract the prepayment credit in Item 8 from the total tax due in Item 5. Enter the result in Item 10.

**Item 11.** If you are filing your return and paying the tax due on or before the due date, multiply the total tax due in Item 10 by .12 percent (.0012) and enter the result in Item 11. (Prepayment. See instructions for Item 8.) Note: Do not take the discount if the return and/or payment is not timely.

**Item 12.** If you requested that a prior payment be made as a prepayment be applied to this period, a prepayment from the Comptel's office will include this amount in Item 12.

**Item 14.** Penalty and interest  
 • 1-150 days late: Enter penalty of 5 percent (.05)  
 • 151-360 days late: Enter penalty of 10 percent (.10)  
 • Over 360 days late: Enter 10 percent (.10) penalty plus interest. Calculate interest at the rate indicated unless it was negotiated with you or call the Comptel at 1-877-667-2624 for the applicable interest rate. Note: An additional \$500 late filing penalty will be assessed each time a return is filed after the due date.
