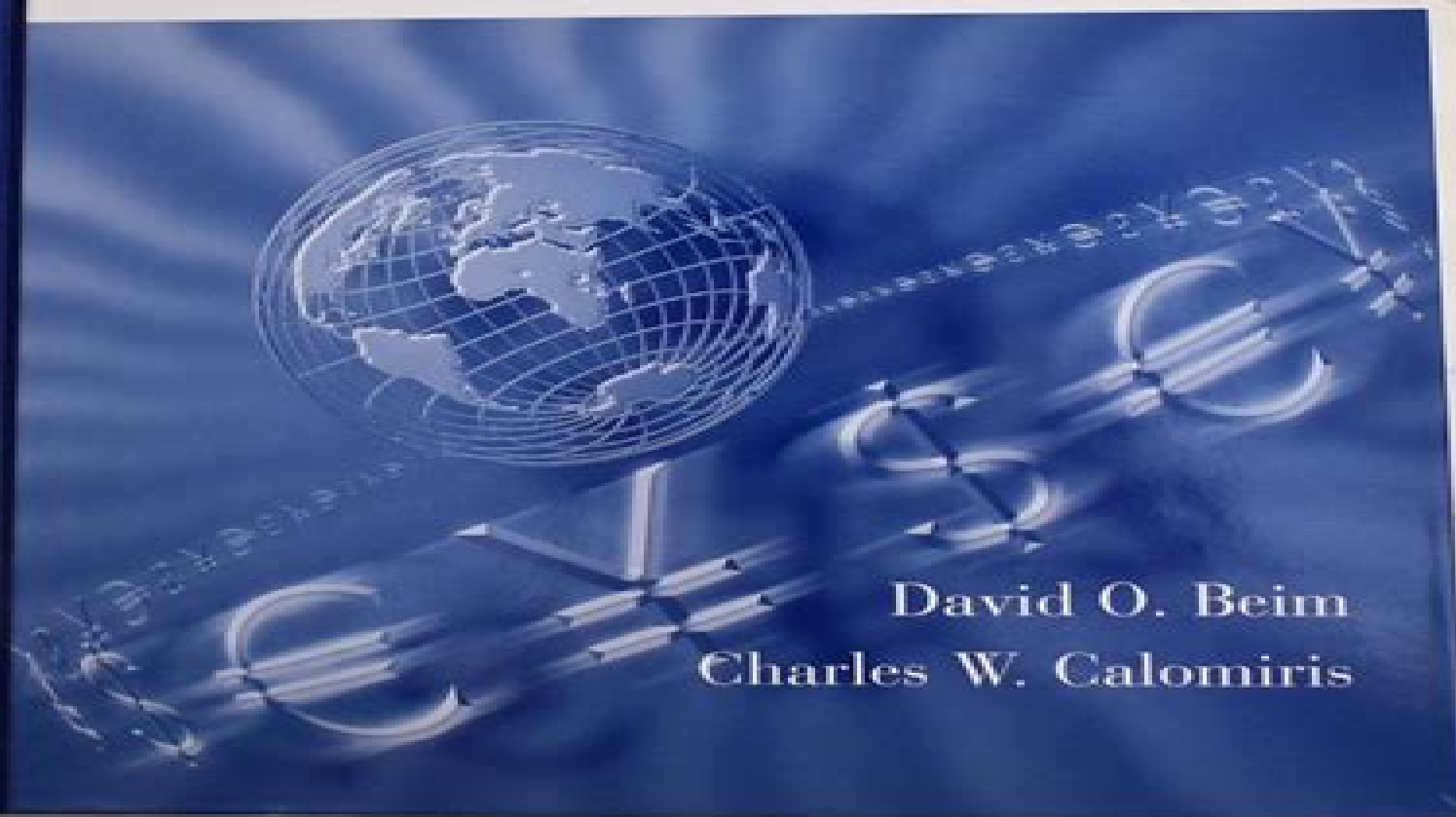

How Does Trade Evolve in the Aftermath of Financial Crises?
