England which demonstrates that some axes of cross topographic movement used as droveways and generally considered as early medieval can be shown to be of prehistoric origin One reason that dryland routes have proved difficult to recognise is that insufficient attention has been paid to the parts played by riverine and maritime longer distance communication It is argued that understanding the origins of the paths we use today contributes to appreciation of the distinctive qualities of landscapes Appreciation will help to bring about effective strategies for conservation of mutual benefit to people and wildlife by maintaining and enhancing corridors of connectivity between different landscape zones including fragmented nature reserves and valued places In these ways an understanding of past routeways can contribute to sustainable landscapes communities and quality of life
