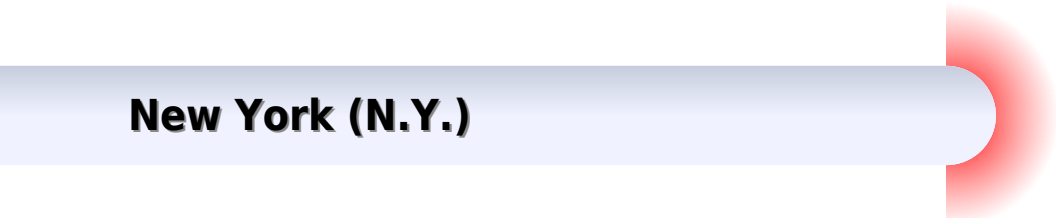
- 1.1.1. A partnership agreement stipulates the amount of capital and other assets that each partner is going to contribute to the business.
