The law of evidence encompasses the rules and legal principles that govern the proof of facts in a legal proceeding. These rules determine what evidence must or must not be considered by the trier of fact in reaching its decision and, sometimes, the weight that may be given to that evidence. The law must ensure certain guidelines are set out in order to ensure that evidence presented to the court can be regarded as trustworthy.
