

Federalist Papers

Background Information: There were two groups of people at the Constitutional Convention: the Federalists and the Anti-Federalists. The Federalists supported the ratification of the Constitution. The Anti-Federalists opposed its ratification. James Madison, Alexander Hamilton and John Jay who were Federalists wrote a series of essays called the Federalist Papers to encourage support for the Constitution. Below is an adapted excerpt from Federalist Paper #4 written by John Jay.

Federalist Paper #4 (Adapted), John Jay

1. But whatever may be our situation, whether freely united under one national government, or split into a number of confederacies, certain it is, that foreign nations will know and view it exactly as it is; and they will act toward us accordingly.
2. If they see that our national government is effective and well administered, our trade regulated, our military properly organized and finances managed, our credit re-established, our people free, and united, they will be much more likely to develop a friendship than provoke resentment.
3. If on the other hand, they find us without an effective government (each State doing right or wrong) or split into three or four independent republics or confederacies, one favoring Britain, another France, and a third to Spain, and perhaps played off against each other in their eyes, what a poor pitiful figure will America make in their eyes!

1. What is Jay's main idea in excerpt 1?

Jay's main idea is that foreign nations will understand if the United States is a united or divided country. These countries will act differently toward the United States if it is divided rather than united.

2. What does Jay say will be the outcome if the national government is efficient?

Jay says that foreign countries will want to support and make friendship with the United States if it has an effective government with regulated trade and people who have rights.

3. What does Jay say will happen if the United States has an ineffective and divided government?

Jay says that if the United States has an ineffective and divided government that other countries will know this and it will affect how these countries view the United States on the world stage. They will view them as being weak ("pitiful figure").

4. How is these excerpts advocating for the ratification of the Constitution?

These excerpts advocate for the Constitution because the Constitution has a strong federal government that will unite the United States more than the Articles of Confederation which was more of loose union of states. Under the Constitution, foreign countries will view the United States as a stronger power it will want friendship with.

By enshrining checks and balances in a constitution designed to protect individual liberties, they argued, fears that central government would oppress the newly free people of America would be allayed. The constitution that the three men helped forge governs the US to this day and it remains the oldest written constitution still in force anywhere in the world.
