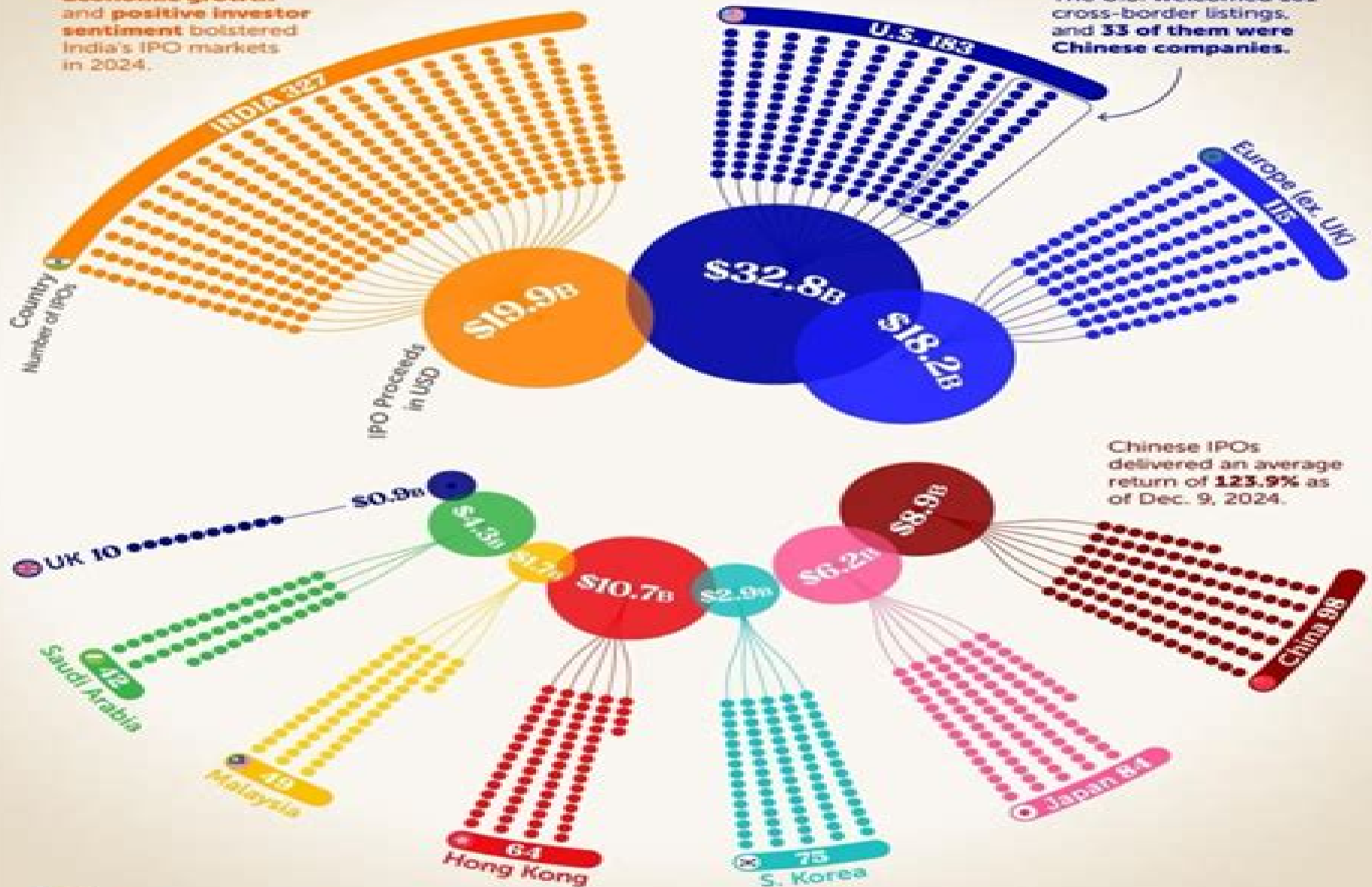


Global IPOs IN 2024 BY COUNTRY
