HISTORY OF PRESENT ILLNESS (chronology and progression, pertinent positive and negatives)

Patient, an 82 year old Caucasian male, was in his usual state of health until 2 weeks ago, when he experienced sudden onset shurred speech, dizziness, weakness in his right leg which precipitated a fall in his home. These complaints began after his daily exercise. Dizziness and weakness continued unabated until 4 days ago, when his wife brought him in for a check-up. He was subsequently admitted for testing to rule out stroke. He reports that his dizziness has improved since admission, and is currently 3- 4 out of 10. He has no history of such symptoms. Patient attributes his symptoms to a stroke, but is concerned that they may be due to amyotrophic lateral sclerosis.

Medical history is significant for hypertension, diabetes, high cholesterol. Additional complaints include rhinitis (a side effect of medication for benign prostatic hypertrophy), depression, and longstanding hearing loss.
