How did Qin Shihuangdi create a strong central government?	Qin Shihuangdi ruled by Legalism, and created a strong central government by appointing censors, government officials, to ensure that everyone's job was being done.	
How did Qin Shihuangdi unify China?	Qin Shihuangdi • created one national currency. • created a canal to connect the Yangtze River to the city of Guangzhou. ◦ The canal was used to ship supplies to troops.	
How did Qin Shihuangdi help protect China and increase its wealth?	Several rulers of Northern China warded off the Xiongnu nomads of the Gobi by building walls. These walls were then connected and strengthened to create the Great Wall of China.	
Despite the positive effect Qin Shihuangdi had on China, he was viewed as an oppressor. Why?	Qin Shihuangdi affected many different class members negatively, unappealing to his people, causing them to rebel.
